Manager Irene Cafferky took the opportunity to acknowledge the work that the ELC/SAC Providers (Voluntary Management Committees and Owners), Childminders and Parent & Toddler groups do on a daily basis to provide support to Children & Families throughout County Roscommon by saying 'The Staff & Volunteers within these services play a vital contribution to children's development within local communities and our CCC acknowledge the current challenges the sector is experiencing with staff recruitment and retention being particularly challenging for services. Our CCCs ongoing commitment to progressing national policy at local level within our overall strategic plan would not happen without the collaboration of many statutory and non-statutory agencies and this collaboration and coordination of resources at local and national level has enabled us deliver on our goals as a CCC. I want to thank our elected representatives for their ongoing collaboration with Roscommon CCC team and wish those newly elected the very best. Irene went on to say 'Developments within the sector which our CCC have supported include the Core Funding Model, National Action Plan for Childminding, Access & Inclusion Model, Services Quality Action Plans, the local delivery of the national Tusla Always Children First programme, training and workshops, supporting the sustainability of community ELC/SAC services and the compliance of all services with funding programmes and Tusla regulations. Our CCC also continue to offer support to services with governance best practice and HR, pre-development of new services and will be supporting the rollout of the Equal Start model as that evolves.
